



## Police Threat Response Program

### POLICING CHALLENGES

---

When systems fail and a violent incident occurs, police are called upon to respond to the threat. In the aftermath, departments may face criticism for using force or failing to prevent the incident because the perpetrator was "known" to the police. However, traditional law enforcement practices are not always suited to prevent targeted acts of violence or provide the sustained services needed to mitigate threats. The Federal Bureau of Investigation, National Center for the Analysis of Violent Crime, further articulated the challenge as:

*"Traditional law enforcement techniques historically have focused on the apprehension and prosecution of violent offenders after violent crimes are committed. When police are given information that someone may potentially commit a crime or become violent in the future, their responsibilities, authorities, and available investigative tools are suddenly less clear." (FBI NCAVC, 2018).*

Federal law enforcement agencies such as the United States Secret Service, Federal Bureau of Investigation, and the United States Capitol Police have operationalized behavioral threat assessment into protective intelligence and investigative protocols. Likewise, police departments across the country are implementing threat management units to respond to the rising frequency and severity of active shooter attacks. However, not every police department has the resources to stand up a threat response unit. If sufficient resources do exist, how does the department identify quality training? Police departments face two formidable challenges:

1. Changing from a reactive to a proactive policing approach to preventing violence and adverse police encounter with community members in crisis.
2. The complicated process of balancing public safety with the needs of a community member of concern.
